Resolution to Honor President Leroy M. Morishita

WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 14,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

WHEREAS, Dr. Morishita has announced his retirement beginning Dec 31, 2020¹, after leading the university for nine years, since June 2011, and being Cal State East Bay's (formerly known as Cal State Hayward) fifth University President since its founding in 1957²; and

WHEREAS, among many of his accomplishments, President Morishita has 40 years of experience in higher education as an Educator, Coordinator, Counselor, Director, Chair Administrator, CFO, Vice President, and as Cal State East Bay's President; and

WHEREAS, his hard work and tireless efforts towards student success has helped graduate more than 40,000 students, of which approximately 50% were first-generation students, as well as leading Cal State East Bay's highest-ever fundraising, exceeding the goal of \$65 million during the 2016 - 2020 Rising in the East Campaign; be it therefore

RESOLVED, that Associated Students Inc. of Cal State East Bay would like to extend a lifetime membership to Dr. Morishita, including but not limited to, admission to ASI sponsored events (ie: ASI Banquets, Meetings, etc.) as a token of appreciation on behalf of all Pioneers for his dedication and influence; and to extend best wishes as he nears his well-earned retirement;
