WHEREAS, Associated Students, Incorporated (ASI) of California State University, East Bay (CSUEB) is the recognized voice of approximately 16,000 students; and

WHEREAS, it is the mission of the ASI Board of Directors to advocate and provide responsible and effective leadership for a diverse student population in order to make sound decisions for the betterment of CSUEB students; and

WHEREAS, the purpose of the ASI Senate is to serve as the governing body of the students of CSUEB as the ASI Senate, to advance the cause of CSUEB students, and to provide programs and services designed to meet the varied needs of CSUEB students¹; and

WHEREAS, the California State University Chancellor Timothy White announced in May 2020 that the CSU campuses will conduct most of their Fall 2020 courses online²; and

WHEREAS, most classes for CSUEB will be online for the 2020 summer and fall terms³; be it therefore

RESOLVED, that the ASI Senate meetings shall take place online using video conferencing software, such as Zoom; and

RESOLVED, that the dates for these meetings will be as noted: November 12 and December 3; and
